"Total PIB JK registered and not registered as many as 88,199,427 soul "[2]. Through these data it can be said that the amount of POM in Indonesia until the beginning of 2014 recorded approximately 88 million people.

According to Tri (2011) states that there are some inherent characteristics of the population being poor, namely (1) low income or no income, (2) Do not have a steady job, (3) low education, even uneducated, (4) not have residence, (5) Nonfulfillment of minimum nutritional standards [3].
