ABSTRACT: The main purpose of this study was to analyze the availability of female primary and secondary education in Pakistan and solutions of the hurdles in healthy enrolment ratio about the availability and effectiveness of female education in Pakistan. Analyzes of efforts taken for improving the female education at primary, secondary and higher levels in Pakistan and critically analyze the causes of low enrolment of female and drop-out ratio of female especially in less privileged areas The scope of the study was limited to all the teachers and students of government female schools working in the education department The main objectives were around the effectiveness of female education and opportunities available for female. The total sample size was 150 teachers and students randomly selected by from schools randomly selected by five districts in Karachi. A Likert Rating Scale has been used for this study. It has 10 items having five points scale. The data were analyzed through the use of chi-square tests and percentages, the hypotheses have been rejected and concluded that the female education trend should be started from home than society and the media can play a better role. In light of the findings, some solid recommendations were made.

The female teachers should be appointed for female, and the media can play a vital role for promotion of female education in Pakistan There is a need to appoint more female teachers in schools, again the media can play an important role to motivate female towards education also published banners can be distributed through newspapers and door to door distribution with the cooperation of welfare local organization and flexible additional money reserve for the female education along with strong observation and evaluation process.

CONCEPTUAL FRAMEWORK

In April 2000, World Education Forum organized conference in Dakar, Senegal, all representatives of the participating countries committed to the attainment of the following six goals, the first one is expanding and improving comprehensive early childcare and education, the second one is access to compulsory primary education of good quality, third one about the learning needs of all young people and adults are met through equitable access to appropriate learning and life skill programs till 2015, fourth one is about gender disparities in primary and secondary education achieving gender equality in education by 2015, fifth one about the with an ensuring girls' full and equal access to and achievement in basic education of good

quality and the sixth about the Improving all aspects of the quality of education and ensuring excellence of all, so that recognized and measurable learning outcomes are achieved by all, especially in literacy, innumeracy, and essential life skills [3]. Shaikh, clearly mentioned that the Dakar declaration is very important and challenging, especially for Pakistan is one of the signatories to both the declarations and education especially primary education which is considerable at priority bases although emphasis since the inception of Pakistan and has been treated as a major issue in education policies but despite intention and effort, the results are discouraging for Pakistan education system [4].

Pakistan's main problem is the out of school children and the population age group between 5-9 years is 19.634 million in Pakistan but 3.300 million children are out of school which means that the dropout rate is 31.3% at the primary level and 30 % at the middle school level and the given population growth of 1.9%, attainment of EFA goals within the stipulated period would require huge investments still heavy task for the country with limited resources like Pakistan [3]. The promoting of female primary and secondary education in Pakistan can achieve social, economic, physical and all human development moreover gender equality in the Pakistan education system. Female education of any country always improves the development process that boosts their worth and women are frequently larger than that of men not only in Pakistan but all over the world as well and the outcomes of female education can see in the reflection of health, child protection, schooling and mental development [5]. Lower rate of female education especially in Pakistan damaging socioeconomically cultured and healthy environment, as all know that the educated mother can play a better role than an ordinary low or uneducated mother who does not care her kids in basic informal and formal education, a negative sign on economic growth in any level of human capital [6].In developing countries, female education impacts the whole picture of economic growth and reduces infant mortality led to the foundation of strong children's education [7]. Female education in Pakistan not be promoted in any stage by family especially less developed rural areas where the boys also support their parents in earning for family needs and the more developed areas the gender inequality in education directly affects country economic growth. In Pakistan education system there are the slots in recruitments of teachers on merit, limited resources however not properly utilize and gender inequality in education all giving negative impact of social, economic and political growth [7].

Education mainly an important part of the country's development and the developed country used this golden principle of progress; it has an inverse relationship with poverty to provide employment opportunities for the people [8]. The Pakistan ranking in gender inequality and empowerment is nearly a hundred according to the UNDP report 2010, which is very disappointing and surely not supporting the positive social and economic condition. It has been observed that male dominant society which mainly more marked in the rural and tribal areas indigenous laws and customs creating a lot of problems for the country [9].

Nowadays Pakistan's "Gross Enrollment Rate" for primary education is 70 percent; the tragedy is that out of 50 percent of children leave school before class five rests of the other hardly pass primary school education [10]. Everyone has a right to access to education without any gender bias; this is an ethical thing for the equality of mankind and an integral part of the nation's progress and development. Both men and women are an essential part of society even fallow the basic Islamic education under the hijab the woman still can work with the man. Female generally outclass male in the examination, and they are also higher achievers in universities, unfortunately, the majority of the girls never get an opportunity to develop their educational capabilities [9].

Last ten years the conditions of improvement in literacy female rate still not satisfactory for Pakistan, for example, the literacy rates in urban and rural areas were 58.3% and 28.3% respectively in the year 2006 and hopelessly were 12% among rural women [12].

In 2006, the Federal Bureau of Statistics, Pakistan announced that female enrollment was recorded highest at the primary level to some extent but dropped out at the secondary school and college levels. According to the bureau report less than 3% of age group girls of 17–23, have access to higher education in Pakistan. The motivation towards female education is essential for better Pakistan; even religious education also emphasizes basic learning. The urban area female almost have full opportunities than the rural areas, they have a tendency to develop their personality through education looks very much on target, it is, therefore, the

enrolment ratios are very healthy in cities which is started right at primary education can say a backbone of education. The parents in urban areas allow these girls to enroll in school and encourage their girls to pursue a good academic career and more motivated to stand up for their education for a better future of the country too [13].

Pakistan's system of education is missing some important aspects of moral and civil society mentioned in the constitution of Pakistan. Iqra the world in Quran clearly shows the rate of education mandatory for all human beings not only for man but also the woman who is an important part of society especially for the growth of youngsters. Another disappointment can be seen that the UN development supported Programs not properly manage in the education sector and only one-third of a woman approximately receive a basic primary and secondary education and only 2.7% public expenditures on the education of the GDP in Pakistan, pay harmful outcomes in future. Ignorance, old family thoughts and lack of emphasis on the importance of female education those females who loses her basic rights and opportunities to polish hidden talent for the growth of her capability is one of the major problems of gender inequality in Pakistan education system and missing the significance to the development of society which can produce intellectuals [14].
